(1) He will not claim any TA/DA/TP/joining time for the purpose of transfer and he will rank junior in the gradation list of the new unit, including all persons who have been approved for appointment to that grade on that date and he will un-conditionally agree to accept the seniority in the gradation list of the new unit as laid down in Rule-8 of BSNL's Employees Transfer Policy dated 07-05-2008 and amended thereafter time to time.

(2) The official will not seek re-transfer to his parent unit before completion of 5 years of service in the transferred Circle.
